REACTOR OVERSIGHT PROCESS PANEL TO MEET IN ROCKVILLE, MARYLAND

The Nuclear Regulatory Commission's Reactor Oversight Process Initial Implementation Evaluation Panel (IIEP) will hold its first meeting November 1 and 2 in Rockville, Maryland.

The NRC established the panel to obtain advice and recommendations on the revised reactor oversight process in accordance with the Federal Advisory Committee Act (FACA). The panel will independently evaluate the results of the first year of implementation of the revised reactor oversight process. It will provide its views and advice on possible revisions to the program in a written report.

On March 28, in approving initial implementation of the revised reactor oversight process to more than 100 commercial nuclear reactors, the Commission directed the NRC staff to convene an evaluation panel under FACA to evaluate the first year's experience.

The panel includes NRC staff from headquarters and regional offices, the Union of Concerned Scientists, the Georgia Department of Natural Resources, the California Energy Commission, the Nuclear Energy Institute, and representatives from licensees.

The November 1 and 2 meeting, which is open to the public, will be held in conference room T-8A1 of the agency's Two White Flint North Building at 11545 Rockville Pike.
