In 2016, the National Archives and Records Administration (NARA) issued a Controlled Unclassified Information (CUI) rule to standardize the way executive branch agencies handle information that requires protection but is not Classified National Security Information. In order to transition NRC to a CUI program, the staff recommends the initiation of a rulemaking. The rule would update NRC's regulations by making nomenclature changes, such as replacing the term "sensitive unclassified non-safeguards information," or SUNSI, with "controlled unclassified information." The rule would also resolve substantive conflicts between NRC's current regulations and the requirements of the CUI rule. For example, it would revise existing document marking instructions that are inconsistent with the CUI rule. I agree that such a rulemaking is necessary to implement an effective CUI program and approve the staff's recommendation.


